The Breeder Agrees:

That this puppy is in good health and has had a vet visit at the time of sale. The purchaser will have 72hrs in which to have the puppy examined by their own veterinarian. If the puppy is found to be ill by a licensed veterinarian and is to be returned due to illness, a letter from the veterinarian is required. Purchaser shall assume any expenses associated with returning the puppy to the seller. The seller will, at the seller's discretion, refund the purchase price, return the dog to the buyer in healthy condition, OR exchange the dog for another dog of equal value. At no time and under no circumstances will the Breeder be responsible for any veterinary expenses incurred by the purchaser.

This animal is warranted against FATAL GENETIC Defects for 2 years from the date of purchase. Should this puppy be determined to be suffering from a fatal defect deemed to be hereditary (within 2 years from the date of purchase), breeder will replace the puppy with one of the same value when one is available after notification and written verification has been furnished to the Breeder by TWO independent veterinarians immediately upon the knowledge of such case. The breeder will not be responsible for any veterinary costs at any time.

We cannot guarantee that your puppy will never develop any health problems, some things are just not able to be predicted. Our parents are free of diseases, disorders, and health problems; otherwise we would not breed them. That means our puppies are less likely to develop problems. If anything does occur, you are required to inform us so we can evaluate the parents and the other puppies from that litter in an attempt to determine the cause of the ailment and to eliminate the issue from our breeding program.

Breeder does NOT GUARANTEE against COCCIDIA or GHIRDIA (typically dormant single celled parasites common in puppies) or for final adult weight, color, breeding ability, show potential or against overbites, under bites, patella issues, hernias, trachea issues or for undescended testicles. BREEDER agrees to notify PURCHASER if they or the vet discover any of the above problems prior to sale. By initialing, you agree that you have read and understand what BREEDER does and does not guarantee for. _____ (initial)

<u>Vaccinations & Health Check</u>: Puppies are given their first puppy vaccinations, wormed, and vet checked before shipping. All puppies are released in a healthy state to the best of our knowledge. Maternal antibodies may interfere with early vaccinations. Therefore, follow up vaccinations should be administered by your veterinarian every 3-4 weeks until after 16 weeks of age. Failure to give vaccinations may result in a potentially fatal disease such as Parvo. Heartlove shall not be held responsible for health issues caused by infectious disease, hypoglycemia, malnutrition, accident, injury, or neglect. Please see your puppy's health record for details on the health care your puppy has received while with the breeder.

The purchaser agrees to finish all puppy vaccines before taking their puppy out in public, letting their puppy on public sidewalks and grasses, or letting their puppy be touched by people outside of the family. This reduces the chance of your puppy picking up a communicable disease such as parvo.

The Purchaser, New Owner Agrees:

That this puppy will be given adequate and proper shelter and housed securely indoors. This dog shall not be neglected, allowed to roam free, or be mistreated in any manner. The puppy shall receive proper veterinary care throughout its life, receiving annual inoculations and placed on a heartworm preventative. The puppy shall receive proper nutrition and care shall be taken to maintain its proper weight. Buyer agrees to give the dog proper training and socialization. Buyer agrees to never sell or surrender this dog into a dog fighting institution, testing center or shelter.

The new owner agrees to return the dog to the Breeder, <u>Heartlove Poms</u> if for any reason the new owner no longer wants or is unable to keep the dog. Breeder agrees to either assist in finding another suitable home where the dog will receive proper care or to accept the dog back at any time with no refund to be given to the new owner as Breeder would accept responsibility for the dog and will be responsible for the future cost of care including vet care and training. The new owner will notify the Breeder of any changes of address and will maintain contact throughout the life of this dog. The new owner will register the puppy with the AKC prior to 1 year of age.
